InterAct is a tool that visualises data about crime and related activity by district across Hampshire, Isle of Wight, Portsmouth and Southampton, making it accessible to community safety practitioners and supporting them to produce consistent strategic assessments for their area.

INTERACT KEY FEATURES



INTERACTIVE DASHBOARDS

Data is visualised in interactive dashboards using data visualisation software.



The filters available may include variables such as victim, offender, crime or geographical characteristics.

Using drop-down menus the user can adjust the charts without prior knowledge of query building, and generate insights into issues faced by communities in their area.

An introductory narrative and supporting information provide context to aid data interpretation.

One single data compilation being used across multiple geographic areas allows for greater consistency and comparability.

COMMUNITY SAFETY PARTNERS

Our core data owners are members of the Community Safety Partnerships, which comprise of police, local authorities, fire and rescue authorities, probation service, and health.

Community Safety Partnerships have a statutory duty to annually assess local crime priorities and consult other agencies and the local community about how to deal with them.

Each partner is a key stakeholder in the data that is being shared for the purpose of producing consistent strategic assessments for their area.



QUALITY DATA

The data is provided by our partners and the Office for National Statistics, and is quality assured by the data owners.

The data is assimilated in a way that provides the maximum use across districts and unitary authorities.

Data monitoring, compliance with the Information Sharing Agreement and prioritisation of development needs is conducted through the Information Management Board chaired by the Police and Crime Commissioner's office.
