Thank you for contacting the office of the Police and Crime Commissioner for information about Hate Crime. Your request was received on 27 August 2019 and given the reference FOI00347.

You have requested the following information:

Request 1:

Is tackling hate crime included in the Police and Crime Commissioner's current priorities?

Response 1:

Hate crime is a recognised priority in the Police & Crime Commissioner's Police and Crime Plan "A plan to keep us safer" 2016 – 2021. It falls within the strategic priority to "strengthen partnerships, to work together to reduce crime, promote public safety and create vibrant and inclusive communities".











To help tackle hate crime in Hampshire and the Isle of Wight, the Commissioner has:

- Increased the number of third party reporting centres (TPRCs) from 3 to 60.
- Produced literature such as posters and information leaflets which are freely available to TPRCs and the public to download and use.
- Funded the victim care service which supports victims of hate crime.
- Commissioned services to help tackle hate crime (see full list below).
- Worked with the business community to create a business guide for tackling hate crime.
- Funded the Heartstone Odyssey Project to tackle intolerance and prejudice.
- Helped produce a new prejudicial languages toolkit aimed at infant/junior and secondary schools across our policing area.
- Supported a pilot for out of court disposals for low level hate crime offenders.

Response 2:

The Commissioner does not allocate a specific amount each year to tackle hate crime. To date the Commissioner has invested over £100k to help tackle hate crime, this includes running an entire small grants round, solely focussed on hate crime projects in 2016/17 when 12 projects were funded.

Each of the Commissioner's safer communities grants round (two run per year), include hate crime as a commissioning theme. To date the Commissioner has funded the following projects/services to help tackle hate crime:

Hate Crime Small Grants Round 2016 / 17

- Awaaz FM Community Radio (Southampton) (£2,000)
- "Shout Out Against Hate Crime" Radio programme targeted at minority ethnic audience / communities to raise awareness of Hate Crime.
- Communities First Wessex (covering East Hampshire) (£2,952)

"Love Diversity" Supporting LGBT young people by providing emotional and mental health support to those experiencing Hate Crime and discrimination.

Cultural Media Enterprises (Southampton) (£3,000)

Devising, writing, recording and broadcasting a radio drama incorporating verbatim accounts of the experiences of hate crime victims and experiences of reporting crimes alongside original drama and music created by a cast of local young people.

• Eastleigh Community Safety Partnership (£2,000)

Development of Hate Crime leaflets and literature for Third Party Reporting Centres in the borough.

Gosport Safety Partnership (£300)

Promoting of the Third Party Reporting Centre at the Gosport Discovery Centre.

Motiv8 South (Portsmouth) (£2,878)

Development and delivery of the Respect Programme which is part of the PREVENT agenda, delivering 10 workshops to young people which will also include Hate Crime.

Motiv8 (Gosport and Fareham) (£2,996)

Creating a DVD around the growing problem of hate crime for wide distribution.

Saints Foundation (Southampton) (£2,100)

Delivery of 12 interactive Hate Crime workshops at 12 Southampton schools / venues aimed at young people.

Spring Arts & Heritage Centre (£2,976)

Theatre in schools, performance of the play "Labels", to 800 students in four schools which raises awareness of intolerance in various guises.

Safer Communities Fund 2019/20 (Large)

Age UKIW (£34,000)

LGBTQI Hate Crime Support Project. We will raise awareness and develop practical solutions to enable victims of homophobic/trans-phobic/bi-phobic hate crime feel protected and supported.

In addition the Commissioner funded the Heartstone Odyssey Project (£24,000) in 2017/18, to tackle prejudicial languages and behaviours in schools.

We are encouraging everyone organising hate crime awareness events throughout the year (not just during the national week) to let us know so that we can place markers on the National Hate Crime Google Map that we have set up to show where events are taking place across the UK (URL link below).

The map aims to promote existing events and activities across the UK whilst also enabling us to see which areas are addressing hate crime and which areas are not.

Response 3:

The Commissioner is unable to identify the total number of events which are being run across the entirety of the Hampshire policing area, however the Commissioner will be part of two specific events during hate crime awareness week this year.

The launch of the Hate Crime guide for businesses which has been created in partnership with Enterprise cars and will be launched at their UK headquarters in Egham, Surrey. On the 14th October.

The Commissioner will also be involved in the launch of the prejudicial languages toolkit on the 15th October in Winchester. The toolkit includes a new pro forma for recording hate crimes in school, a new annual survey aimed at young people in schools to understand the level of hate crime and how it is being challenged from their perspective and a new leaflet aimed at parents, to inform them that prejudicial language and behaviour is not acceptable.
