#### **Decision title**

Supporting suicide prevention and intervention on the Isle of Wight to keep people safer and reduce the impact on frontline policing

## **Executive summary**

A whole community approach to suicide prevention is an essential activity that benefits everyone. It not only achieves proactive response to those struggling with difficult life circumstances but also reduces the demand for policing services and the additional support to families and loved ones. The charity to provides an immediate operational suicide response on the Isle of Wight and will help to reduce the impact on police officers' time and response.

The initiative will help to keep vulnerable people on the local community safer and supports the Commissioner's priority to strengthen partnerships and deliver effective and efficient policing.

The thermal imaging equipment to be funded will help to undertake more effective searches at a well-known and potential suicide risk areas. It will also assist in the location of vulnerable individuals more quickly and support the team in getting them to a place of safety.

This additional camera that is to be provided through this funding will build on the excellent outcomes achieved in the last year. The equipment to be provided builds on previous grant funding provided by the Commissioner in June 2020. This further support will enable services to be based at another location on the Isle of Wight for use by a second emergency team at a base on the other side of the island which is known as another high-risk area.

#### Recommendation

The Commissioner agrees to provide funding of £2,500 to contribute towards the purchase of a thermal imaging camera to help in supporting and locating vulnerable individuals of higher risk of suicide. This initiative will also reduce the time required of frontline police officers.

# 1 Summary

The Commissioner has been approached to contribute funding towards a thermal imaging camera for Suicide Prevention and Intervention on the Isle of Wight. Funds have already been raised locally towards the cost of the camera in the region of £3,000 and the Commissioner's contribution is the final amount required to enable to the important equipment to be purchased.

The local charity on the Isle of Wight has seen an increase in calls when the camera could be used. The thermal imaging camera will help to seek out and trace bodies at a well-known potential risk area, which includes suicide risk. It will help to locate vulnerable people more quickly and get them to a place of safety.

The charity provides an immediate operational suicide response on the Isle of Wight and will help to reduce the impact on police officers' time

and response. The camera can also be used when a police helicopter is not available.

The initiative will help to keep vulnerable people on the local community safer and supports the Commissioner's priority to strengthen partnerships and deliver effective and efficient policing.

### 2 Recommendation

The Commissioner makes the contribution of £2,500 towards the purchase of a thermal imaging camera to support with suicide prevention and intervention thereby helping to keep lives safer.

### 3 Strategic context

The initiative will help to keep vulnerable people on the local community safer and supports the Commissioner's priority to strengthen partnerships and deliver effective and efficient policing.

### 4 Options appraisal

A request for a contribution toward a first thermal imaging camera was received in June 2020, when a grant of £1,000 was made. This additional grant funding provides for an enhanced option that will expand the service to the whole Island.

#### 5 Timescales

The payment will be made on formal approval of the Decision Request to enable immediate action to be taken.
