You have requested the following information:

“The number of services commissioned by the Office of the Police and Crime Commissioner in the past 12 months for:

- a. Child Victims of Child Criminal Exploitation*
- b. Child Victims of Child Sexual Exploitation.*

Information which is not currently available is as follows:

Frankie Worker Service - *The Frankie Worker Service is commissioned to support those aged 0-18 years, identified as Tier 4 who have experienced sexual abuse, assault, rape, violence or exploitation. There are 3 Frankie Worker Services – Hampshire, Isle of Wight and Portsmouth. The providers are No Limits for Hampshire and Portsmouth and Barnardo’s for the Isle of Wight (the FOI request is from Barnardo’s). These three services are commissioned by the Local Authority who hold the 3 individual contracts and the funding is provided by the OPCC and Integrated Care Boards (formerly known as the Clinical Commissioning Groups). The Hampshire and Isle of Wight Services were commissioned more than 12 months ago (the timeline for this FOI request) and the Portsmouth Frankie Worker Service was awarded by Portsmouth City Council in April 2022. Contracts for all 3 end 30th September 2023. The OPCC are commissioning the new Frankie Worker provision to start 1st October 2023 but due to the procurement process we are unable to provide any information externally of what will be within that specification.*

Independent Sexual Violence Advisor (ISVA) Service - The ISVA Service was commissioned in 2022 and the service commenced April 2022 to provide ISVA support across Hampshire (including Portsmouth and Southampton). This contract is held by the OPCC and funded by the OPCC and Hampshire, Portsmouth and Southampton councils. The provider of the

	<p>Hampshire ISVA Service is Yellow Door. The contract is due to run until 2029. The service is an all-age service for adults, children and young people providing practical/emotional support and advice to those who have experienced sexual abuse, assault, rape, violence or exploitation at any point in their lives, irrespective of whether they have reported to the police. The provision includes supporting individuals to report a crime if they wish to do so and provides support throughout the criminal justice process. The IOW ISVA Service provider is Hampton Trust. The IOW ISVA Service is part of the wider DA/SV contract and does not specially support those who have been victims of exploitation – this contract ends September 2023 and the OPCC are currently in the process of commissioning a new ISVA Service for the Isle of Wight to start 1st October 2023 but due to the procurement process we are unable to provide any information externally of what will be within that specification.</p>
