### Your request under Freedom of Information Act (FOIA)

Thank you for contacting the Office of the Police and Crime Commissioner requesting information about **Police estate** Your request was dated **3<sup>rd</sup> August 2023** has been given the reference **HA4086**

*I've been trying to find a spreadsheet containing the full list of Hampshire PCC's estates that they own and upkeep. Unfortunately, the only one I could locate was from November 2020.*

*Would it be possible for you to send me an updated version, preferably a list that covers June 2023?*
