SUPPLEMENTAL INFORMATION SHARING AGREEMENT

- 1. This agreement is supplemental to the Information Sharing Agreement dated 3/2/2025 made between the Chief Constable of Isle of Wight (The Chief Constable) and the Police and Crime Commissioner for Hampshire and the Isle of Wight (The Police and Crime Commissioner.)
- This supplemental agreement is to made to address the sharing of information by the Chief Constable with the Police and Crime Commissioner to assist the Police and Crime Commissioner's independent review (the review) of Hampshire and the Isle of Wight Professional Standards Department (PSD).
- 3. The Information Sharing Agreement dated 3/2/2025 at paragraph 3 (2) (b) permits the sharing of information so that the Police and Crime Commissioner may exercise their statutory oversight scrutiny function of the police complaints system. The Chief Constable will share material relevant to the review pursuant to paragraph 3 (2) (b). In the first instance the material will be redacted to exclude the Officer and third party details. These details will be supplied if their relevance is demonstrated. For the avoidance of doubt material that is already in the public domain does not require redaction.
- 4. The Police and Crime Commissioner has appointed Weightmans LLP to carry out the review. The Chief Constable will share material relevant to the review with Weightmans LLP as the Police and Crime Commissioner's agent pursuant to paragraph 3 (2) (b).
- 5. Weightmans LLP shall (a) Only use the information shared for the purpose of the review (b) Shall not share with third parties documents shared relating to specific complaints and conduct investigations unless such documents are in the public domain
- 6. Paragraph 5 is without prejudice to any obligation to disclose documents by compulsion of
- 7. Weightmans LLP and the Police and Crime Commissioner shall retain and dispose of all material obtained in the review in accordance with schedule 1 of this agreement.
- 8. Save as stated above all of the terms of the information sharing agreement dated the 3rd February 2025 apply to this supplemental agreement.
